


During Annual Session each year, there is a ceremony to give out the Gold Crown awards. You can consider it the Academy Awards of ASDA. This year MU ASDA took home the biggest prize, the Ideal ASDA award. This means that Marquette ASDA was recognized as best overall chapter in the nation in the following categories: Membership and Communications, Advocacy Initiatives, Activities, Fundraising and Predental.

That is right MUSOD: your ASDA chapter was voted most ideal in the nation!

The winning chapter is selected by ASDA's Ideal Award Committee. This committee consists of members of the Council on Membership and other national leaders. They utilize ASDA's standards of excellence award criteria to select the winner. Chapters submitted a written application and video summarizing their year and achievements to be reviewed.

For the second year in a row, MU ASDA also walked away with the award for Best Use of Chapter Video. We were praised for our annual music video, "Policy for Dummies" series and other MU ASDA videos.

Congratulations to all members of MU ASDA. Special thanks to those who helped construct the application and to all those involved in MU ASDA!

What is Annual Session?

ASDA's Annual Session brings together hundreds of students from all U.S. dental schools. It is the official annual meeting of ASDA's House of Delegates , when ASDA elects national ASDA leaders, and where Gold Crown Awards are decided. Attendees also hear from prominent speakers, attend spotlight sessions, and go to networking events throughout the weekend.

And the Winner is...

A large part of annual session was electing new leaders. President and Speaker of the House candidates first addressed the House of Delegates. Individual candidates then rotated through each group of districts , or caucuses. Each caucus had prepared interview questions . Some caucuses had candidates do ridiculous actions or tasks while answering. After interacting with each candidate, caucuses voted on who they wanted for the executive committee and for speaker. The 3 candidates with the most votes were elected to the executive committee. ASDA's president was chosen from these three by a second vote. Similarly, candidates for district trustee went through the caucus procedure and were voted on by delegates from their respective districts (Congrats Tyler Robers!).

Bringing Down the House

The House of Delegates is the supreme legislative body of ASDA and is responsible for electing officers and determining policies, initiatives and directives. Resolutions were proposed and delegates had time to speak in favor or against the resolutions. After debate, two members from each school act as chapters delegates and voted on their chapters behalf. These two delegates voted on these resolutions as well as voted for executive committee and speaker of the house candidates. Next year's house of delegates will be led by our very own Ryan Twaddle!

VIP's

Over 650 dental students attended this year's Annual session. Throughout the week there was ample time to meet student leaders from other schools, whether it be from your own district or across the country. Attendees were able to network and socialize at the welcome reception, sponsored socials, as well as in collaborative breakout sessions. These breakout sessions include time to collaborate and brainstorm ideas to bring back to our own chapter. The sessions were on many topics including wellness, advocacy, membership, fundraising, and leadership and organization. Spotlight sessions included topics such as alternative careers in dentistry and how to find the right practice for you. Additionally, there was time to network at the Dental Expo with potential employers, mentors, and vendors to utilize as your careers progress.

esolutions? Made at the beginning of the year?" you might be asking yourself after reading the title. "Like, flossing twice a day, not eating between meals, and hitting the gym eight times a week?" No! We're not talking about New Year resolutions, people. We're talking about ASDA Resolutions. These Resolutions are formal requests or actions presented to the House of Delegates at ASDA Annual Session every year. There are 132 delegates, two from

each ASDA chapter, and they are responsible for discussing the proposed resolutions in order to determine policies, initiatives and directives. The best part is, any ASDA member can write a resolution! If you have a problem that you think needs to be addressed or a policy that you think needs to be amended, go to https://www.asdanet.org/utility-navigation/about-asda/leaders-and-governance/House-of-Delegates/How-to-Write-a-Resolution to start writing your very own resolution to be voted on next year!

The Resolutions that were adopted by the 2018 House of Delegates at annual session this year fall into three categories: Education and licensure, Membership and Professional Issues, and Governance. Education & Licensure

There were three 'adopted' (i.e. approved) resolutions regarding education and licensure, but the hot button resolution this year revolved around evidence-based prescribing. With the approval of Resolution 205-2018, ASDA took a stance encouraging dental schools to provide increased education on evidence-based prescribing. The resolution outlined that dental schools should provide resources for dental students to appropriately address opioids with their patients, and that the American Dental Education Association should create resources that establish evidence-based prescribing practices for dental school clinics. The other two approved resolutions revised language of already existing policies. For example, Resolution 206RC-2018 emphasized the importance of interprofessional collaboration by adding "The American Student Dental Association supports opportunities for interprofessional education and collaboration with other healthcare professions to improve the understanding of oral and systemic health" to the B-3 Interdisciplinary Dental Education policy.

Membership & Professional Issues

Issues this year focused less on membership and more professional problems, specifically sustainable solutions to reduce barriers to care in underserved communities. Adopted Resolution 306-2018 called for methods "efficacious and sustainable in reducing barriers to care in underserved communities. These measures include, but are not limited to, early intervention, Medicaid expansion and co-location of health services." Two additional policies –C-2 and H-1—were amended to create a more comprehensive position on the dental student's role in addressing barriers to care. Additionally, wording re-

garding ASDA's position on teledentistry was modified to support radiographs and screenings performed by licensed dental hygienists and assistants.

Governance

If you're ever curious about how ASDA operates or you're thinking about running for a national position, check out specifics at ASDA's "Dental School Administrative Policies and Student Government" page because each policy is scrutinized yearly by the national Governance Committee (https://www.asdanet.org/utility-navigation/ about-asda/leaders-and-governance/currentstatements-of-position-or-policy/dental-schooladministrative-policies-and-student-government). All governance resolutions at annual session this year were amendments to clear up existing policies. Thrilling topics such as who can nominate the speaker of the House and how much experience they need, streamlining the process by which new pre-doctoral chapters are confirmed, and logistics of reference committee reports were all discussed by the House of Delegates.

You Shall Not Pass:

Resolutions that were not adopted

It's not all flowers and fellowship on the House floor. There were two resolutions this year that were evaluated by the House and not adopted. Resolution 302-2018 proposed amending ASDA's current policy 'C-2 Functions of Dental Providers'. It endorsed licensed dental hygienists, dental therapists, and expanded function dental hygienists—under the supervision of a dentist—to performed exams, prescribing work authorizations, performing irreversible dental procedures, and prescribing medications. The second resolution that did not pass was resolution 406, 'Amendment to Current Statements of Position or Policy 'E-3 School Closings". The object of amending this policy was to clarify that fourth year dental students should be able to graduate in case of a dental school closure. In the end, the delegation could not decide on specific wording of the resolution, so it was sent back to the Governance committee to hash out the lingo.

Develop a standardized leadership training and transition program for chapter and district leaders.





Evaluate current business model and develop strategies to achieve financial organizational sustainability.

ASDA's

National Strategic Plan:

Every three years the national leaders along with the Board of Trustees develop a strategic plan that encompasses the goals of ASDA on a national level in order to advance and aid individual chapters and districts. At this year's Annual Sessions, the 2018-2020 ASDA Strategic Plan was announced as the following:



Develop a plan and promote the value of ASDA to dental school administrations to increase support of student involvement.



Evaluate current member benefits and recommend changes to increase member value.

This new strategic plan will now be implemented over the next three years, specifically within the Board of Trustees.
